## Prof. Yemi Osinbajo Vice President Of Nigeria

Oluyemi Oluleke Osinbajo, SAN, GCON, is the Vice President of the Federal Republic of Nigeria. Born on March 8 1957 at Creek Hospital, Lagos, Yemi is a professor of law and a Senior Advocate of Nigeria. He is maried to Oludolapo Osinbajo (nee Soyode), granddaughter of the late sage and statesman, Chief Obafemi Awolowo. They are blessed with three children.

#### Education

Yemi's early years in primary school were spent at Corona School Lagos. Between 1969 1975, he attended lahabi College, Yaba where he was the winner of the State Merit Award (1971); the School Prize for English Oratory (1972): Adeobo Prize for English Oratory (1972-1975); Elias Prize for Best Performance in History (WASC, 1973): School Prize for Literature (HSC, 1975); and African Statesman Intercollegiate Best Speaker's Prize (1974).

Thereafter, he studied for his undergraduate degree of the University of Lagos between 1975-1978 when he obtained a Second Class Upper Degree in Law. Here, he also won the Graham-Douglas Prize for Commercial Law. In 1979, he completed the mandatory one year professional training at the Nigerian Law School whereon he was admitted to practice as a Barrister and Solicitor of Nigeria's Supreme Court. In 1980, he attended the London School of Economics & Political Science, where he obtained a Master of Law degree.

#### **Professional Life**

An accomplished scholar, teacher, lawyer and administrator, Yemi is one of the nation's leading experts on the Law of Evidence, National and Regional Corporate Commercial Laws and Public Law.

From 1979-1980, Osinbajo participated in the one-year youth service programme as a Legal Officer with Bendel Development and

From 1979-1980, Osinbajo participated in the one-year youth service programme as a Legal Officer with Bendel Development and Planning Authority (BDPA), in the now defunct Bendel State, Nigeria. In 1981, the University of Lagos, Nigeria, engaged Osinbajo as a Lecturer. From 1988-1992, he was appointed as an Adviser [Legal Advice and Litigation), to the then Attorney-General of the Federation and Minister of Justice, Prince Bola Ajibola, KBE.

In 1994, he become a Professor of Low following which he was appointed Head of Department of Public Law, University of Lagos. Between 1999 and 2007, Osinbajo was Member of Cabinet of the Lagos State Government where he served as Attorney-General and Commissioner for Justice. From 2007-2013 Osinbajo was once again employed as a Professor of Law, Department of Public Law, Faculty of Law, University of Lagos. In 2007, Osinbajo became Senior Partner at Simmons Cooper Partners, Nigeria (a commercial law practice).

#### **Political Career**

After the formation of the All Progressives Congress (APC), Prof. Yemi Osinbajo was tasked with other notable Nigerians in the party with the development of a manifesto for the new political party. This culminated in the presentation of the "Roadmap to a New Nigeria". a document published by APC as its manifesto in 2013. The highlights of the Roadmap included a free meal school plan, and a conditional cash transfer to millions of the poorest Nigerians if they enrol their children in school and immunise them.

On 17 December 2014, the presidential candidate of the All Progressives Congress, retired General Muhammadu Buhari, announced Osinbajo as his running mate and vice-presidential candidate for the 2015 general elections.

On 31 March 2015, the Independent National Electoral Commission (INEC) confirmed the Buhari/Osinbajo ticket having won the Presidential election, thus Osinbajo became the Vice President-elect of Nigeria. They were both sworn in on the 29th of May 2015 for the first term. Earlier this year in February the Buhari/Osinbajo ticket wonthe Presidential Elections for a second term in office starting May 29, 2019.

Other past roles of Professor Osinbajo include: Staff Member, United Nations Operations in Somalia, Justice Division, UNOSOM II. Member, United Nations Secretary General's Committee of Experts on Conduct and Discipline of UN, Peacekeeping Personnel around the globe, Member, 2006. Partner in Law Firm of Osinbajo, Kukaxi & Adokpaye.

Yemi is a member of the International Bar Association and the British Institute of International and Comparative Law and has served on the Nigerian Body of Benchers and the Council for Legal Education of Nigeria. He was also an independent director of CitiBank Nigeria and an ethics adviser to the board of the Africa Development Bank (ADB). He has authored several books. Reform & Charity Work

While in public office as Attorney General, Lagos, Yemi is credited

with undertaking far-reaching significant judicial reform in Lagos State, addressing critical areas as judges' recruitment, remuneration, training and discipline. In addition, he addressed access to justice for the poor by establishing appropriate institutions in the Office of the Public Defender (OPD) and the Citizens Mediation Centre (CMC).

Yemi founded the Orderly Society Trust (OST) involved in an Excel Literacy Programme that aims to provide children in public primary schools with the same level of training in English as is available to their counterparts in private schools. Yemi also co-founded Justice Research Institute (GTE), a justice sector think-tank, as well as the Convention on Business Integrity.

As a spiritual leader, Osinbajo has organized various initiatives that work towards social justice. He organizes the Liberty Schools Projectthat provides free primary school education with free school lunches to poor children. This Project has three sites in poor communities in Obanikoro, Ikota and Makoko, all in Lagos. Other initiatives include free health care facilities, free legal services, social rehabilitation, skills acquisition for the very poor, a regular soup kitchen service, and free shelter for young people without accommodation.

He is an ordained Pastor of the Redeemed Christian Church of God, and an Emeritus Ambassador for the Environment in Lagos.

## Saratu Umar

Executive Secretary & CEO Nigerian Investment Promotion Commission (NIPC)

Ms. Saratu Umar is the Executive Secretary & Chief Executive Officer of the Nigerian Investment Promotion Commission (NIPC), who was appointed by the President of Nigeria on July 5, 2022. She is a Technocrat, Reformer, Strategist, Economist, Investment Promotion Expert, Export Development specialist and Banker, who has over 30 (thirty) years cognate experience in the Banking and Finance as well as Investment and Consulting segments of the public and private sectors of Nigeria. A 1989 Graduate of B.Sc. Economics from the prestigious Ahmadu Bello University Zaria, Nigeria, she holds an MBA degree with specialisation in Finance and Banking.

Ms Umar was first appointed to head the NIPC in 2014. During that time, she embarked on corporate reforms with a vision to make the institution an African Industry Leader as well as "a gold standard of excellence on the African Continent and a world-class Investment Promotion Agency". This was to enable NIPC play a central role in the Nigerian investment eco-system as well as in national development as envisaged by its Act. Prior to this, Ms Umar who is deeply passionate about the socio-economic development of Nigeria, spent over 20 (twenty) years in development banking at the Nigerian Export-Import Bank which she joined in April 1992 as a pioneer staff and traversed as well as headed almost all strategic and key operational departments of the Bank. This included Trade Finance, Project Finance, Business Development and Advisory Services, Strategy, Credit Insurance and Guarantees, Human Resources Development, Administrative Services, and Board Secretariat/Legal Affairs Department.

Ms Umar started engaging in international assignments for Nigeria, about eleven [11] years before being appointed to lead the NIPC; spanning a decade, Ms Umar undertook economic diplomacy

assignments for the Country and also served as speaker in several Trade Missions in Europe, America and Asia aimed at seeking investors for Nigeria. She also participated in bilateral and multi-lateral negotiations and engagements, and meetings with Heads of Missions/Ambassadors both locally and internationally in different capacities on behalf of the country. Ms Umar is a visionary and result-oriented Leader who is deeply passionate about the socio-economic development of Nigeria and who aims at the attainment of stake and shareholder expectations for a positive impact.

She has garnered a diverse range of skill-set which include: Credit Analysis and administration encompassing Project Finance, Trade Finance and Guarantees; Business/Export Development and Diversification; Communication and Presentation; Economic Diplomacy; Investment Promotion and ability to synergize these with socio-economic development. She served Nigeria in many capacities, including chairmanship and membership of numerous technical committees, amongst them, as Member and Secretary of the Nigerian President's Honorary International Investor Council (HIIC) which was chaired by the President and Commander-in-Chief of the Armed Forces, vice-chaired by the Vice President of Nigeria and coordinated by Baroness Lynda Chalker. Its membership also comprised some members of top Nigerian and international business community, industry leaders, opinion leaders and policy analysts. The Council was aimed at shaping future policy to affect business climate; and advising the President on priority areas of economic activity, improving Nigeria's business and investment climate, as well as advising the President on value-added strategies to attract FDI and improve Nigeria's competitiveness amongst others.

Lamido Abubakar Yuguda, the Director General of the Securities & Exchange Commission (SEC) Nigeria, has over three decades of experience in central banking, accounting, finance, economics and investment management.

He spent 32 years at the Central Bank of Nigeria (CBN) in various roles, including leading for 16 years, a team that successfully managed reserve assets that grew to tens of billions of US dollars. In 1997, he joined the International Monetary Fund (IMF) Washington DC, on a four-year stint as an economist in the Africa Department. He served in several departments of the CBN, and retired in 2016 as Director of Reserve Management.

Mr. Yuguda earned a B.Sc. degree in Accounting in 1983 from Ahmadu Bello University, Zaria, Nigeria and an M.Sc. in Money, Banking and Finance in 1991 from the University of Birmingham, United Kingdom. Morgan Government Bond Index - Emerging Markets (GBI - EM) in October 2012 which made Nigeria the second country in Africa, after South Africa to have its local currency sovereign bond included in the Index thereby attracting foreign investors to Nigeria's domestic bond market as a whole.

In July 2017, Patience Oniha was appointed as the Director-General, DMO and under her watch, Nigeria successfully issued its debut N100 billion Sovereign Sukuk and debut Green Bond for N10 billion that same year. With her at the helm of affairs,

Nigeria has raised over N612 billion through the issuance of Sovereign Sukuk for the construction and rehabilitation of roads and bridges across Nigeria. Similarly, over N20 billion was raised through Green Bonds to finance renewable energy and afforestation amongst others, making Nigeria the first country in Africa to issue a Green Bond and the fourth country to issue a Green Bond globally.

Ms. Oniha obtained a B.Sc. Economics, First Class Honours from the University of Benin in 1983 and went on to earn an M.Sc. Finance from the University of Lagos in 1985. She is also a member of the Institute of Chartered Accountants of Nigeria in 1990 and a Fellow in 2008. She is also an Associate Member of the Chartered Institute of Taxation of Nigeria.
