- Low Non-Oil Export Revenue
- Inadequate Foreign Reserves
- Political:
  - (i) Elections had sustained effect on portfolio investments due to uncertainty
  - (ii) Changes in Central Government at period of economic challenges





- 2016 YTD (April) turnover in the FX market (Spot and Derivatives) settled at \$34.36bn, a circa 50% (\$34.13bn) drop on YoY comparison
- The YTD (April) turnover value translates to an average daily turnover of \$430.00mm (2015 -\$835.00mm)
- FX Spot accounts for 64% of turnover

- FX rates (across the three (3) market tiers) remained relatively flat in the months of March and April
- Volatility also tapered within the period, especially in the parallel market as rates ranged at an average of \$/₩318.00
- The CBN clearing (official) rate remained unchanged over the period, whilst inter-bank rates inched up by 60kobo
- Liquidity in the FX market remains very low, and funding business operations continues to pose a serious challenge for many businesses. Cost of doing business has risen, with firms heavily exposed to Dollar-denominated obligations and/or production costs having to cut back on production and size of their workforce

## **Policy Reforms & Responses**

The Federal Government of Nigeria and the Central Bank of Nigeria (CBN) have responded to the challenges in the FIC markets with a combination of fiscal and monetary policies with the aim of stimulating growth in the local economy. These include:

#### **Fiscal Policies:**

- Increased Government spending on capital projects to build the infrastructure needed to support growth in the local economy
- Support for non-oil sectors of the economy, that contribute to real GDP growth amidst the global low oil-price regime

#### **Monetary Policies:**

The sectors referenced above are also the focus of monetary policy via the following actions:

- Tightening of monetary policy
- Documentation and implementation of a new FX Management Framework
- Introduction of Yuan/Naira Liquidity via a currency Swap
- Boosting access to credit through various intervention funds and schemes



### **Returning Liquidity and Price Formation to the FIC** Markets../2

Recommendation	Key Considerations
Operate a market- determined exchange rate	<ul> <li>For improved competitiveness of the economy, the forces of demand and supply should be allowed to determine the FX rate, via the inter- bank market. This will encourage efficient allocation of resources and bolster investments</li> </ul>
Implement a single FX market structure	<ul> <li>The inter-bank market should become the recognised FX market</li> <li>The FX inter-bank rate to become the official reference rate for ALL transactions</li> <li>All Government-allowed imports to be funded in the inter-bank FX market. This will render the parallel market, which is without governance, transparency and credibility, insignificant</li> <li>Government to use punitive tariffs to discriminate against imports and promote local manufacturing efforts via rebates</li> <li>CBN to intervene in the market and end its burden of responsibility for exchange rate adjustment</li> <li>All administrative controls to be discarded to redirect energy towards the price stability mandate</li> </ul>

Recommendation	Key Considerations
Boost supply of FX to the market	<ul> <li>Encourage foreign portfolio investors in the fixed income market by raising interest rates</li> <li>Federal Government and the private sector to articulate mediumterm and long-term strategies to boost foreign currency supply and reduce import dependence</li> <li>CBN to present reform programs to the market to promote transparency and build confidence</li> </ul>
Develop liquid inter- bank FX hedging products	<ul> <li>Inter-bank market to introduce hedging products to reduce the pressure on the FX spot market, improve business planning and inspire hope and stability</li> <li>CBN to support the inter-bank FX market and its development of hedging products</li> </ul>




